SUBJECT	EDU 6 & 7 - Educational Program and Remedial Education Course Update

- I. Biosketch Review Update:
 - a. All dental hygiene educational programs have been reviewed.
 - i. One program is outstanding:
 - 1. Two faculty members lack Educational Methodology and will complete requirements by January 31, 2018.
 - ii. Two RDAs teaching radiology dismissed.
 - iii. Four faculty without Baccalaureate Degrees were dismissed.
 - b. SLN Requirements
 - i. Three RDH licenses cleared for SLN qualifications.
 - ii. Four RDH licenses did not have Nitrous Oxide-Oxygen Sedation qualifications.
 - 1. 3 RDHs will not be assigned to oversee Nitrous Oxide-Oxygen Sedation.
 - 2. 1 RDH retired.
 - iii. One RDH license did not have Soft Tissue Curettage/Nitrous Oxide-Oxygen Sedation qualifications.
 - 1. RDH was dismissed.
 - iv. One RDH license does not have Soft Tissue Curettage/Local Anesthesia/Nitrous Oxide-Oxygen Sedation qualification.
 - 1. RDH is taking SLN course.
- II. Site Visits
 - a. Two programs visited for general compliance.
 - i. Carrington College - San Jose
 - 1. Some violations were discovered.
 - 2. Working with school to bring into compliance by January 2, 2018.
 - ii. Taft College – Post informal conference
 - 1. Some violations remained, so withdrawal was affirmed.
 - b. Plans to visit all schools in the future to check their status and for general compliance.
 - i. Update on Concord Career College – Garden Grove
 - 1. A site visit is planned to ensure general compliance of the law.

III. Remedial Education Providers

- a. Due to students having repeated failures requiring remediation, a few programs have applied to be remedial education providers.
 - i. Southwestern College approved.
 - ii. Cabrillo in process.
